

Privacy Policy

This privacy policy applies in relation to the website located at www.ceosleepoutza.co.za (the “website”). The website is owned by The Philanthropic Collection (Pty) Ltd (Registration no. 2016/093005/07) and operated by Humanity and Co (Pty) Ltd (Registration no. 2017/029869/07) (together “The 2018 SleepOut™ Movement”). The Information We Collect

PayFast processes all credit card transactions on our website and is a Payment Card Industry Data System Security (PCI DSS) Level 1 compliant entity.

How We Use This Information

The 2018 SleepOut™ Movement may use aggregate or anonymous information for these uses for itself and third parties.

Who We Share This Information With

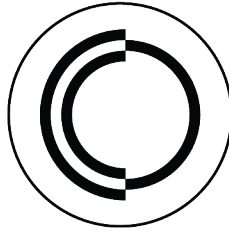
Security
